SB 960/HB 1087 – Bradley/Rooney – Relating to Protection of Motor Vehicle Dealers' Consumer Data – CSFS/Comp Law

• No issue with bill

SB 1220/HB 1021 – Garcia/Steube – Relating to Award of Attorney Fees in Public Records Enforcement Actions – CSFS/Biz Lit/Comp Law;

• Possible concern with bill to be raised with committee

SB 1414 – Simmons - Relating to Cyber Harassment – Comp Law/IP;

• Modification to "revenge porn" 2015 FL law that looks to better define whereby victim had expectation of privacy; Mark Rendaza has 5 page article against the passage of the bill

SB 1146 – Montford – Relating to Student Data Privacy – Comp Law/IP

Fiduciary Access to Digital Assets – Presentation by Nicole Valdivieso, Esq.

- Allows fiduciary with the authorized access, control and/or copy to User's digital assets, such as facebook account. Originally proposed in 2015 by died after Facebook and Google opposed.
- Online tool must be available at all times

- If online tool is available, the online tool would override any secondary authority, including a will. However, the requesting custodian would still be able to seek a court order for access.
- Facebook currently has a legacy account option
